**Custodial History:** The permits, records, and other papers in this collection were generated by Tampa's Barrio Latino Commission between 1969 and 1978. They were part of a body of records stored in the old Centro Español building in Ybor City. This body of material included records from the Ybor City Chamber of Commerce, Latin Quarter Art Gallery, and Ybor City Rotary Club. The papers were apparently left in the building at the time the Centro Español club moved out in 1983. The papers were transferred to USF Special Collections in March, 1990 by the Trust for Public Land at the same time as the Centro Español de Tampa Records.

## Biographical Note

Created by law under City of Tampa ordinance number 2642, the Barrio Latino Commission is responsible for preserving the distinct architectural integrity and character-defining features of the Ybor City historic district. Functions of the Commission are to review applications for building permits submitted for structures within the boundaries of the Barrio Latino section, defined as follows: 4th Avenue on the south, Columbus Drive on the north, Nebraska Avenue on the west, and 22nd Street on the east. In order to ensure compliance with Ybor City design guidelines and standards, permit applications for construction or alteration of buildings within the Barrio Latino Section must be submitted by owner to the Commission for design review.

## Scope Note

The records of the Barrio Latino Commission include architectural drawings and plans, correspondence, financial records, construction permits and permit applications, as well as petition approvals for construction, demolition, repair, and other alterations to structures located within the geographic boundaries defined by the commission. Meeting minutes and agendas are also included, in addition to preliminary drawings for buildings located within the Ybor City urban renewal boundaries.

*Arrangement Note:* Records are primarily arranged alphabetically by type of material. Correspondence and meeting minutes are organized chronologically by date, while construction permit applications are filed by street name.
